# **Penn State Alumni Association Automatic Renewal Program Terms**

Your Penn State Alumni Association membership can be conveniently renewed at the start of each membership year when you sign up for automatic renewal. This means that on the anniversary date of your membership, you will automatically be charged for the next membership year to guarantee uninterrupted access to benefits. An email reminder will be sent prior to your membership renewal date so that you'll know exactly when the transaction will take place. This message will contain any reminders or action required on your behalf.

#### **Your Authorization**

You authorize the Penn State Alumni Association to initiate the payment amount indicated on this form/above for your Penn State Alumni Association membership.

### **Amount of Charges**

The total price stated on this form is the cost for one (1) year of membership in the Penn State Alumni Association. This amount will be charged to your card today for one (1) year of membership. This total does not include the cost of future periods of Penn State Alumni Association membership. At the end of one (1) year, unless you notify the Penn State Alumni Association to cancel automatic renewals as stated below, your Penn State Alumni Association membership will automatically renew for one (1) additional, one-year period. Thereafter, unless you notify the Penn State Alumni Association to cancel automatic renewal as stated below, your Penn State Alumni Association membership will automatically renew for successive additional one-year periods and your card will automatically be charged, during the month of your expiration, on or about the renewal date, at the then-current membership rate for the applicable category, unless you notify the Penn State Alumni Association prior to your renewal date that you wish to cancel your membership renewal.

#### **Notice of Renewal**

Per your selection during the auto renew enrollment process, the Penn State Alumni Association will send a notification to the email address that you have provided that your membership will automatically renew, notifying you that your card will be charged for the renewal, and notifying you of the amount that your card will be charged for your membership. It is your responsibility to notify the Penn State Alumni Association of changes to your email address and changes to your payment card information. If you have an existing annual membership in the Penn State Alumni Association when you enroll in auto-renew, your membership will renew annually on the anniversary date of enrolling in the program;

however the expiration of your annual membership may extend beyond the payment date. All official membership expiration dates can be found on the membership card mailed to the member's preferred address.

## **Changes to Price of Membership**

The Penn State Alumni Association may change rates for the various membership types. We will notify you of the current cost of your membership on the Notice of Automatic Renewal prior to charging your card. [You are not guaranteed the same rate in perpetuity.] By agreeing to participate in the automatic renewal program, you agree that the Penn State Alumni Association may charge your card the then-current rate for your selected membership. ## **Term and How to Cancel**

The Penn State Alumni Association will continue to automatically renew your membership on an annual basis until you cancel the automatic renewal.
